WILLOUGHBY-EASTLAKE CITY SCHOOL DISTRICT

A majority affirmative vote is necessary for passage.

Shall a levy be imposed by the Willoughby-Eastlake City School District for the purpose of **providing for the emergency requirements of the School District**

in the sum of \$8,500,000 and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average 4.94 mills for each one dollar of valuation, which amounts to 49.4 cents for each one hundred dollars of valuation, for a period of ten years, commencing in 2020, first due in 2021?
