## **JURISDICTION**

1. This Court has original jurisdiction of this action.

#### **STANDING**

2. Relator has statutory standing under R.C. 121.22(I)(1) to bring this action.

## **PARTIES**

- Relator Brian M. Ames ("Mr. Ames") resides in Randolph Township, in Portage County, Ohio.
- 4. Respondent Geauga County Board of Revision (the "BOR") is the county board of revision established by R.C. 5715.02 for Geauga County.

## **STATEMENT OF FACTS**

5. In the year 2020, the BOR consisted of the county treasurer, Christopher P. Hitchcock (the "Treasurer"); the county auditor, Charles E. Walder (the "Auditor"); and a member of the board of county commissioners selected by the board of county commissioners, Timothy C. Lennon (the "Commissioner").

- The BOR met on Monday, January 13, 2020, at 3:03 p.m. in the Auditor's Conference Room on the first floor of the Courthouse Annex. 231 Main Street, Chardon, Ohio (the "Meeting"). (Exhibit 1)
- Present in the Meeting were Chief Deputy Auditor Ron Leyde ("Leyde"), Chief Deputy County Treasurer Caroline Mansfield ("Mansfield") and County Commissioner Gerard Morgan ("Morgan"). (Exhibit 1)
- Also present in the Meeting were Chief Appraiser Chris Greenawalt and Deputy Auditor Rachel Blystone. (Exhibit 1)
- 9. Pursuant to ORC 5715.09, "each County Board of Revision shall organize annually on the second Monday of January be electing a Chairman for the ensuing year." (Exhibit 1)
- In the Meeting, it was moved by Caroline Mansfield, seconded by Ron Leyde to appoint Christopher P. Hitchcock as Board of Revision Chairman for 2020. Voice vote, three ayes. (Exhibit 1)
- In the Meeting, it was moved by Ron Leyde, seconded by Caroline Mansfield to appoint Timothy C. Lennon as Board of Revision Vice Chairman for 2020. Voice vote, three ayes. Ron Leyde, Caroline Mansfield and Gerard Morgan. (Exhibit 1)
- 12. In the Meeting, it was moved by Gerard Morgan, seconded by Caroline Mansfield to appoint the following alternate members for 2020 in the event of a member's absence:

- 13. Authorization of Auditor to Act for Board of Revision
- 14. In the Meeting, it was moved by Gerard Morgan, seconded by Caroline Mansfield to designate and authorize Geauga County Auditor Charles E. Walder to act on the Geauga County Board of Revision's behalf as it relates to all cases appealed from the Board, and grant Auditor Walder the Board's full authority and approval to so act. Voice vote, three ayes. Ron Leyde, Caroline Mansfield and Gerard Morgan. (Exhibit 1)
- 15. In the Meeting, it was moved by Gerard Morgan, seconded by Caroline Mansfield to accept Chris Greenawalt and engage his services to assist the BOR as its real property consultant in determining the market value of selected properties as of January 1, 2019. Voice vote, three ayes. Ron Leyde, Caroline Mansfield and Gerard Morgan. (Exhibit 1)
- 16. In the Meeting, it was moved by Gerard Morgan, seconded by Ron Leyde to remit and/or refund the following late payment penalties totaling \$147.67 due to reasonable cause and not willful neglect and based upon the recommendation of the County Treasurer

18. R.C. 121.22, the Open Meetings Act, applies to the Meeting.

# COUNT 1 Failure To Conduct Official Business In An Open Meeting

- 19. Relator incorporates the above paragraphs as if fully rewritten herein.
- 20. Neither the Treasurer, the Auditor, nor the Commissioner were present in the Meeting.
- 21. R.C. 121.22(C) requires that "[a] member of a public body shall be present in person at a meeting open to the public to be considered present or to vote at the meeting and for purposes of determining whether a quorum is present at the meeting.
- 22. As there were no members of the BOR present in the Meeting, there was no quorum.
- 23. The conduct of the public business of the BOR in the absence of a quorum violated R.C.121.22.
- 24. Neither Leyde, Mansfield, nor Morgan could legally make motions, seconds, or vote in the Meeting.
- 25. All actions taken in the Meeting are invalid by operation of R.C. 121.22(H).
- 26. The conduct of the Meeting was in violation of R.C. 121.22, the Open Meetings Act.

### **PRAYER FOR RELIEF**

WHEREFORE, Relator prays for judgment against Respondent, and that the Court:

- (1) Find that Respondent has committed a violation of the provisions of R.C. 121.22 as set forth in Count 1.
- (2) Issue a mandatory injunction for the violation enjoining Respondent to comply with all the provisions of R.C. 121.22 as mandated by R.C. 121.22(I)(1).
- (3) Order Respondents to pay to Relator a five hundred dollar civil forfeiture as mandated by R.C. 121.22(I)(2)(a).

- (4) Award Relator all his court costs and reasonable attorney's fees under R.C. 121.22(I)(2)(a).
- (5) Any other relief which this Court deems just and equitable.


