



Marxists; leftists; their current terrorist allies in Black Lives Matter and Antifa; their billionaire financiers like George Soros, Bill Gates, Michael Bloomberg, or Jeff Bezos; and corporations are so blatant and open with their attempts to get rid of this most important remaining obstacle that it can hardly be any longer called invisible. Still insidious, but hardly invisible.

Those who lead the attack against police know that community, independent police departments are a key bulwark against completely taking over and establishing tyranny in America. Once defunded or replaced by

less-effective community outreach programs controlled by these same Marxists, crime will skyrocket - as is already happening. Exactly as the leftists planned and hope.

Los Angeles county Sheriff Alex Villanueva points out that criminals, emboldened by the defund the police movement, are behind the soaring murder rates in cities like New York, Chicago, St. Louis, and Baltimore - Municipalities, not surprisingly, controlled by Democrats.

He further points out that murders are up 200% for the first two months of 2021 and that preliminary FBI data shows a 25% surge in murders for 2020. That's the largest single-year increase since the FBI began publishing such data in 1960.

With such an upsurge in crime, their solution will be to call for a national or international police force to restore order, possibly administered through the states. If this trend continues, the United States will have its own version of the Gestapo.

This too is already occurring. Nancy Pelosi, Chuck Schumer, and the Democrat overlords have set up satellite offices for the Capitol Police in San Francisco and Tampa Bay. Why the Capitol Police need offices outside of Washington, D.C. is puzzling.

Local police, on the other hand, are residents, neighbors, fellow churchgoers. Their children go to the same schools, they shop in the same stores, go to the same restaurants. They are local citizens serving their communities.

The solution to stop the nationalization of police is to support your local police and keep them independent of the national, international, and possibly state government, if it merely carries out national or international dictates. Then we can refund the police. That will go a long way toward restoring order.

We don't have to lose our local, independent police departments to Marxists, leftists, Black Lives Matter, Antifa, the defund the police brigades, and their billionaire globalist financiers. We can beat them back, but we must organize in our communities with like-minded individuals

The solution will not be easy. But then, most things worth-while require work. With over 60 years in the making, it will take more than a simple fix to correct it.

More than 5 years ago, we publicly made the following statement: "If we continue on our current path of ever-increasing property taxes, we will price seniors and those living on fixed incomes out of their homes that they have worked all their lives to achieve". We cannot drain the taxpayers of their savings just to have it reside in some rainy-day fund just in case the political sub-division may need it.

THE APPETITE OF THE LAKE COUNTY POLITICAL SUB-DIVISIONS IS INSATIABLE:

- Lake County government recently built a new administration center for about \$35 million.
- Lake County Commissioners are creating plans for a new \$100 million jail.
- The Prosecutor wants more lawyers.
- Lake Metroparks wants more revenue to build their rainy-day fund.
- Fairport Harbor wants \$5 million for a new school for 400 students.
- Riverside School District has plans for a new \$130 million school.
- LakeTran is building a \$17 million new office and garage to store their buses.
- Lakeland Community College wants a renewal on their levy when enrollment is almost half of what it was in 2010.
- Etc, etc, etc...you get the idea....

The Lake County population has grown less than 1% in the last ten years, and although the census for the age of the population is not known at this time, it is widely believed that the population is aging at an alarming rate. That combination of facts when compared to the ever-increasing salaries, benefits and pensions provided in the public sector will prove to be fatal for many seniors.

Now is the time for ambitious actions and scaling the circular



State and local school boards of education and some individual teachers are mandating curriculum and control mechanisms that are preventing the family from deciding what is in the best interest of their children. There is definite movement away from individual liberty to a more "inclusive," collective society promoting "group think" and giving the state far too much control over your children.



A collaborative effort by patriots around the State of Ohio have developed the following ten issues for citizens to use when trying to determine if the candidates for their local school board deserve your vote.

1

Academic excellence being the #1 measurement of district success, the preservation of advanced and accelerated programs, and in-person classroom instruction. 2

A fair, balanced, and accurate presentation of American history, which requires good citizenship and patriotism based on the ideals of liberty, equality, and justice for all.

3

Parents right to know and to consent to any counseling or treatment their child receives.

Sound fiscal stewardship of tax revenue, and accurate reporting of educational performances.

5

Biological males participating in female sports or permitted in women's bathroom areas or vice- versa?

6

Critical Race Theory (CRT), the 1619 Project, and political bias in the curriculum or classroom that turns students against each other and/or their country. 1

Comprehensive Sexuality Education (CSE), Planned Parenthood materials, transgender literature, and attempts to sexualize children through graphic, age-inappropriate presentations of human sexuality. 8

Social and Emotional

family values and privacy,
and expose children to

9

A culture of entitlement that normalizes an ever-expanding role for schools, beyond an educational mission, and beyond a safety net for those in need. 10

Adoption or acceptance of any federal or state programs that might co-opt any of these commitments.



Using children in war situations is not a new phenomenon. They are the most vulnerable to the ruling powers, easily taken from unarmed parents and pressed into service by a government. Czarist Russia drafted children for 20 years, at least 300,000 non-Jewish and 75,000 Jewish Cantonists. Hitler's Germany drafted thousands of young boys known as Hitler youth, indoctrinating them to dedicate their lives for the Reich, unto death if necessary, and most were poorly trained and sent on suicide missions. As many as 40 million children, orphaned by AIDS, and controlled by drugs and religious or political fervor, were recruited in Africa.

Today, nearly 80 percent of about 30 conflicts worldwide have as many as 300,000 young combatants, ages 7 through 15, serving the war effort as scouts, messengers, looters, sex slaves, minesweepers, laborers, makers of bombs and terror tunnels, advance ambush, and suicide bombers. Nearly a half-million

children serve in armies not at war – duped, exploited and wasted.

INDOCTRINATION

The use of children extends to indoctrination. In Islamic shame/honor cultures, the child is forced to learn the Koran with punishment by the whip. bonding them with violence for life. The child bride, often bartered or kidnapped, becomes an uneducated, incompetent and irresponsible mother, who is still dealing with the abuse. anxiety and trauma of having her female identity excised female genital mutilation. The mothers consider their children expendable because they themselves are expendable. Called "the martyr in his mother's womb," the fetus is dedicated to death even before his birth. The cause of Islamic conquest is foremost, and the youths who do survive their horrific experiences are so severely scarred that they will suffer lifelong mental health problems. Despite the changes in war and engagement, the aggressor's agenda is always expansionism, acquisition, domination, and elimination, and the disposable children are sent away for hijrah, jihad by emigration.

AMERICA'S SILENT ASSAULT ON CHILDREN

If war is the annihilation and replacement of one population by another, then America is experiencing a silent assault and eradication. One method of societal reduction or eradication is the promotion of a woman's right to abortion over the right

of the child to live and prosper. The child is mere material, to be used or discarded, as in Aldous Huxley's Brave New World.

The schools are now devaluating sexual differences, first with language, replacing accepted pronouns with gender-neutral terms and, second, with denving the child's nature, in the interest of "complete equality." Teaching staff are encouraging homosexuality, to emasculate the boys and erase the desire for courtship, marriage and reproduction, reinforced by Walt Disney films that encourage a "gay agenda." Family Research Council has just revealed that hours of instruction on evolving "sexual identity," contraceptive drugs and devices, and consenting to sex, are taught in Fairfax County School. The appalling curriculum includes (1) gender fluidity: biological sex is meaningless, (2) embracing gender transitioning. (3) encouraging risky sex, (4) discontinuing abstinence education, (5) teaching use of all

contraceptive devices without divulging health risks, (6) parents may not opt children out of 8th grade comprehensive dating lessons, and (7) stripping the word "clergy" from adult consultants.

Social engineering is another exploitation of children. Groups such as the Boy Scouts was established to prepare boys for manhood, independence, strength, creativity, adventure and the love of God and country, are seeing drastic deviations. In a "celebration of cultural exchange, mutual understanding, peace and friendship," the 2019 World Scout Jamboree event hosted thousands of attendees from more than 200 countries and territories and made condoms readily available. For 108 years, the Boy Scouts of America's flagship program has been known simply as the Boy Scouts. However, with girls soon entering the ranks, the group has since changed their iconic name to Scouts BSA.

BRAINWASHING OUR CHILDREN THROUGH ACADEMIA



America's abhorrent Common Core educational standards reject Biblical and Judeo-Christian values and substitute a cloaked Marxist ideological indoctrination. The storyline is equality of rules and regulations fed by academia to a passive student body and young brains of mush. As in any

fascist system, information is controlled and differing opinions and publications banned. The students are methodically poisoned and their morality shifted from general ethical principles to strengthening the Leftist cause to turn children into obedient Socialist Activists.

Because parents protested Common Core, Jeb Bush deceptively introduced his "personalized learning initiative." The schools and media are promoting a false narrative of multi-culturalism, when the goal should be multi-ethnicities, religions and races, living harmoniously under the host's culture. Migrants to America should be seeking America's peace and prosperity: to deny its existence is to deliberately propose her people's destruction - ethnocide. As such, the accusations of racism and colonization of "white-supremacist Europeans or Americans" prepare the groundwork for the annihilation of our heritage and language. 

Was There Election Fraud in Lake County?

Maybe. Maybe Not.

In our opinion, at the very foundation of our Constitutional Republic is the ability of all citizens to vote for candidates and issues in free and fair elections. It is, therefore, extremely important that the registered voters in Lake County have the confidence in our Board of Election officials and our election process.

What we are about to reveal only deals with Lake County, and we cannot comment on what has transpired in any other state, or county, since we were not even remotely involved.

Why are we coming forward at this time? To sit back and not inform Lake County citizens of what we know would be a betrayal of Lobbyists for Citizens' mission statement. The truth must always be told.

We are continuing to hear that there was definite election fraud in Ohio, and the latest information is that there were 10,834 votes switched in Lake County. These are very damaging allegations. But is it true?

- The continued negativity and doubt about the Lake County election process may drive voters away from the polls thinking why should they bother to vote since the system is rigged.
- 2. The allegations without legitimate proof is unfair to the loyal, hardworking employees at the Lake County Board of Elections; and, quite frankly, Lobbyists for Citizens will not be party to bearing false witness against anyone.

For approximately the last nine months, Lobbyists for Citizens has been working with other like-minded Lake County citizens trying to determine if we could find ANY election fraud issues in Lake County. Our group was so far out in front of other Ohio groups that we were referred to as the "tip of the spear". It was hoped that our group would be able to unlock the key to how election fraud happened in the State of Ohio.

We were working with the Dr. Douglas Frank group and statisticians in the State of Ohio to analyze the voter database information we received from Mr. Ross McDonald, the Lake County Board of Election Director, and the Ohio Secretary of State on-line voter database.

We would like to personally thank Mr. McDonald, and his assistant Mr. Tom Seymour, for their unfailing patience and help in answering our seemingly unending questions, giving access to the public database, and basically, doing everything that we asked of them to better understand their policies and procedures relating to election integrity.

We used the following methods to try to find the phantom voters that everyone has heard about if they have listened to Mr. Mike Lindell and Dr. Frank: (1) robo calls, (2) postcards, (3) knocking on doors, (4) Google Earth software, and (5) a great deal of data analysis.

We have spent an enormous amount of time trying to find thosephantomvoters. However,



we did not find A SINGLE PHANTOM voter. None, Zero, Nada

I objected to any further data analysis when Dr. Frank stated that he had proof of the election fraud in Lake County. I sat across the table from him at a Parma restaurant and said that I would not bear false witness, and he must show me the proof, and it cannot be statistics generated from comparing projected results from a six-number variable polynomial versus actual results. We have waited for over two months, and my patience has worn out. We can conjecture why no proof has been offered, but it would be strictly speculation on our part. The fact remains NO PROOF has been offered.
