Implementation of the school funding formula will include detailed calculations of this funding stream for each school or district. The base cost and restricted component for Student Wellness and Success initiatives is calculated based on the enrolled student population at each school and district. While the funding is computed on an FTE basis, the funds are not exclusively required to support staff.
