WHEREAS, On January 31, 2013, the Board of County Commissioners authorized the advertisement of a request for competitive sealed proposals for an electric filing system for the Lake County Court of Common Pleas and the Clerk of Courts. Said proposals were received on March 6, 2013. The Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of County Commissioners, and that all the deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code, and

WHEREAS, the proposals for an electronic filing system received March 6, 2013 have been reviewed by the Court of Commons Pleas and the Clerk of Courts, who recommend that an award of contract at this time would not be in the best interest of Lake County.

WHEREAS, the Lake County Court of Common Pleas and the Clerk of Courts request an electronic filing system for the Lake County Court of Common Pleas and the Clerk of Courts be cancelled pursuant to Ohio Revised Code Section 307.862 (F) (3).

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County, Ohio, hereby instructs the Clerk of the Board to cancel the requests for competitive sealed proposals for an electronic filling system for the Lake County Court of Common Pleas and the Clerk of Courts.

BE IT FURTHER RESOLVED, that the Clerk of the Board is hereby directed to forward certified copies of this resolution to the Lake County Auditor, Budget Director, Jam Walsh, Lake County Court of Common Pleas; and to Terri Lange – Commissioners' Office.
