shall refer to Salman Pirzada; "Wayne Reed" shall refer to Wayne Reed, Jr.; "Dave Richards" shall refer to David Richards; "Dee Stark" shall refer to Dee Stark-Kurtz; "Phil Stropky" shall refer to Phillip Stropkey; "Bob Tomsich" shall refer to Robert Tomsich; "Chuck Torre" shall refer to Charles Torre; "Darren Spondike" shall refer to Darrin Spondike; "Pat Weaver" shall refer to Patricia Weaver; and "Tom Welk" shall refer to Thomas Welk. Nothing in the instant stipulation shall be construed as limiting the ability of the Parties to correct the name of any individual to reflect the appropriate legal name.

- 3. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for each year from the 2011-2012 school year to the 2020-2021 school year, the Parties agree that Exhibit A contains the total amount of damages that the Board owes to each member for those years and the total amounts that are to be remitted to the State Teachers Retirement System of Ohio ("STRS") on behalf of each member for those years with the exception that any damages owed by the Board shall continue to accrue through the date of final judgment and, accordingly, payment of the 2020-2021 school year amounts shall be pro-rated through the date of final judgment, including amounts due to STRS.
- 4. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for each year from the **2011-2012 school year** to the **2019-2020 school year**, the Parties agree that **Exhibit B** contains the total amount of damages that the Board owes to each member for those years and the total amounts that are to be remitted to STRS on behalf of each member for those years.
- 5. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2011-2012 school year**, the Parties agree that **Exhibit C** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 6. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2012-2013 school year**, the Parties agree that **Exhibit D** contains the total amount of damages that the Board owes to each

- member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 7. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2013-2014 school year**, the Parties agree that **Exhibit E** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 8. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2014-2015 school year**, the Parties agree that **Exhibit F** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 9. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2015-2016 school year**, the Parties agree that **Exhibit G** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 10. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2016-2017 school year**, the Parties agree that **Exhibit H** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 11. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2017-2018 school year**, the Parties agree that **Exhibit I** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 12. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2018-2019 school year**, the Parties agree that **Exhibit J** contains the total amount of damages that the Board owes to each

- member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 13. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2019-2020 school year**, the Parties agree that **Exhibit K** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year.
- 14. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages for the **2020-2021 school year**, the Parties agree that **Exhibit L** contains the total amount of damages that the Board owes to each member for that year and the total amounts that are to be remitted to STRS on behalf of each member for that year with the exception that any damages owed by the Board shall continue to accrue through the date of final judgment and, accordingly, payment of the 2020-2021 school year amounts shall be pro-rated through the date of final judgment, including amounts due to STRS.
- 15. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages, the amounts due to STRS shall be remitted by the Board on behalf of the employer and employee, as applicable, with the Board and individual each responsible for their respective contributions to STRS.
- 16. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages, any interest and/or penalties due to STRS shall be paid for solely by the Board, as determined by STRS.
- 17. To the extent this Honorable Court enters final judgment awarding CATA's current and former members damages, the Board shall be solely responsible for properly and accurately calculating and withholding U.S. Federal payroll taxes, U.S. Federal income taxes, State and Local income taxes, and all other lawfully required withholdings in accordance with the Board's normal payroll procedures.
- 18. Court costs shall be assessed against the non-prevailing party.
